

9. Discussion & approval of RDC Paving invoice to repair the sidewalk in front of 202-205 N Commerce.
10. A brief account of various questions & inquiries directed to the City.
11. Discussion concerning road maintenance in the City of Coupland.
12. Coupland Volunteer Fire Department activity.
